**Guidelines for Financial Aid Application**

This protocol is designed to provide you with information about financial aid.

1. Financial aid is available for families who have a financial need.
2. The following criteria will be used to determine amount of financial aid granted. If the Adjusted Gross Income (as reflected on your IRS form 1040) divided by the total number of dependents claimed is:

Example: If adjusted gross income is \$~~2530~~,000 and there are 4 family members... \$~~2530~~,000 divided by 4 equals \$~~67,250~~500...the student is eligible for \$~~200-200~~ financial aid.

3. A new application must be submitted for evaluation on an annual basis.
4. Financial aid does not cover book and PTO fees.
5. Application should be submitted at The Sunday School office.
6. A counselor will be available to help you in filling out the form.
